DEMOCRACY UNDER PRESSURE

Dear readers,

The Leibniz-sponsored research network "External Democracy Promotion" (EDP) would like to draw your attention to the recent edition of EDP Interactions, the semi-annual newsletter. It comes at a time when democracy is, for the first time since decades, heavily and visibly contested within established democracies. We currently observe how cornerstones of democratic control of power, such as independent judiciary and media, are increasingly undermined by democratically elected leaders – be it in the United States, in Poland or in Germany. Supporting democratic values within Western communities has become an imperative for civil society actors, parliamentarians and journalists alike. Academically, we have to raise doubts about whether or not established knowledge on the level of consolidation of democracies or the concept of checks and balances is still valid. As the



Democracy Promotion Negotiation— Authors Workshop for Special Issue

For its planned special issue on democracy promotion negotiation, the network organizes an authors workshop on May 18 and 19, 2017 at the Peace Research Institute Frankfurt in order to discuss all authors' contributions. Through the analytical perspective of negotiation, the special issue takes into focus the often overlooked dimension of interaction between external and local actors in democracy promotion. Specifically, we are interested in three questions: (1) what actually is on the 'negotiation table' in democracy promotion, (2) which parameters shape these negotiations, and (3) how does the negotiation process matter for the practice and outcome of democracy promotion? We are very much looking forward to interesting discussions and exchanges with a group of authors coming from four different continents.
